Professional Experience:

Ajit Singh is the Chairman of the ACG Group, India. ACG is one of the world's largest and most advanced pharmaceutical ancillaries' manufacturer, with 15 factories located in India, Brazil and the E.U. ACG has achieved a position of the world's second largest manufacturer of capsules and the largest integrated manufacturer of pharmaceutical consumables and pharma packaging machinery. ACG Group's two projects in Brazil making empty capsules and barrier blister packaging films are up and running well, employing over 500 local Brazilians. The Companies in Brazil are exporting also to the USA and other nearby Countries. The ACG Group has won many National and International Awards for technology, including from UNIDO for Technical Training and Research. Also from the World Packaging Organisation (WPO) and the Pharmaceuticals Export Promotion Council of India (PHARMEXCIL) for excellence in design, manufacturing excellence, environment protection and export.

Ajit Singh was a former member of the Central Governing Council of the Indian Institutes of Technology (IITs), and on the Board of Governors of the National Institute of Industrial Engineering (NITIE). He has served as an Executive Committee Member of the Federation of Indian Chambers of Commerce & Industry (FICCI) and headed its Task Force on Nutraceuticals. Also a member of the Confederation of Indian Industry (CII) National Committee on Pharmaceuticals. Invitee member of the CII National Council and a member, Committee and Sub-Committee of the Pharmaceutical Export Promotion Council of India (PHARMEXCIL). He is presently a member of the National Executive Committee of the Indian Drug Manufacturers' Association (IDMA).

Ajit Singh has served as President, Vice President or on the Managing Committees of several of the major Pharmaceutical Associations in India, and Boards of overseas Pharmaceutical Associations. He has received 4 Lifetime Achievement Awards. In Brazil, his Group has been recognized by the Association of Pharma Manufacturers as the "best supplier of pharma equipment and consumables", against global competitors. Ajit Singh was elected to serve as a distinguished member of the Joint India- Croatia Business Council in Zagreb. His Company, ACG Lukaps, in Croatia received the European Business Award for promoting innovation and ethics in the European Business Community, and an Award for the best investment project in Eastern Europe from the Agency for Investment and Competitiveness, and recently, the Golden Key Award for best exporter. He has served on the India Government's 6th 5-year Planning Committee as expert on Pharmaceutical and Ancillary Machinery. He is also a former Chairman of Board of Trustees of the Bombay College of Pharmacy and on the Advisory Board of the Principal Kundnani College of Pharmacy, Mumbai.
