Since then he has led other investments in Latin America in the fields of mining, healthcare, real estate, renewable energy, retail, agriculture, aviation, and technology and has held positions as CEO, Executive Director, and Board member in investments and joint ventures with Brazilian and international banks and companies: AG-Angra Partners (Andrade Gutierrez), Rio Forte Banco Espirito Santo/Haitong (Georadar), Mendes Junior, MMX, Wuhan Iron and Steel and ECE-East China Exploration Bureau (Nanjing).

He is currently the Founding Partner of Top Capital Partners Investimentos, an investment holding company, Managing Partner of Keystone Asia Pacific Investments Limited in Hong Kong, President of Prosper Global Investment Corp USA, Partner of Top Aequitate Partners in Lisbon, Managing Director of EC Ventures and a member of the Global Business Development team of Hyperloop Transportation Technologies in Los Angeles. Tim has a Bachelor of Science in Business Administration - International Business and Marketing from The American University in Washington, D.C. and an Advanced Certification in Corporate Finance from Fundação Dom Cabral (FDC).

In 2017 Mr. Chen was appointed by the US State Department's Mission to Brazil to the Board of Directors of The Fulbright Commission- Brazil and is an official agent to the Minas Gerais Investment and Trade Promotion Agency (INDI-InvestMinas), a member of the Advisory Board of FCJ Venture Builder in Brazil, former member of American Chamber of Commerce (Amcham) board, member of the Hong Kong General Chamber of Commerce and member of the advisory board for international relations of the Commercial Association of Minas Gerais (ACMinas).
